# INCREASE SECURITY AT SEA



As piracy attacks and international terror increase, International Maritime Organization (IMO) states new regulations in order to increase the security at sea.

### IMO regulations

The regulations from IMO covering the International Ship and Port Facility Security Code (ISPS) and Ships Security Alert (SSAS) require ship owners worldwide to implement new routines and new equipment on board ships.

### Capsat® Ship Security Alert

Thrane & Thrane offers two solutions, which fulfil the IMO requirements regarding SSAS. Both solutions are based on the Inmarsat-C service provided by Inmarsat, known for its unique role in maritime safety. The equipment used is Thrane & Thrane's Inmarsat-C and mini-C terminals, which both are approved for maritime use.

The background for the new SOLAS resolution 6 introduced by IMO concerning SSAS is to provide ships with two alarm buttons, which

can be activated in case of a terrorist or piracy attack. The Capsat® Ship Security Alert solutions present the owners with the following benefits:

- Based on the existing Inmarsat-C service, which is recognized for its unique role in maritime safety.
- The Capsat® Ship Security Alert systems are approved by Inmarsat according to CN137, which means that any alert will be handled like a distress in the GMDSS network.
- One time cost only. No additional start up fee/ subscription fees.
- Total flexibility in routing to e-mail addresses, anti piracy centres, GSM phones, etc.
- Both Capsat® Ship Security Alert systems offer the opportunity to use additional fleet tracking software, which will enhance Vessel Monitoring Systems (VMS) and fleet tracking possibilities.

### Capsat® Ship Security Alert/TT-3000SSA

The stand-alone solution will provide the owner with an independent SSA solution, which is simple to fit. No interfacing with existing satellite or radio equipment is required.

### Description of the TT-3000SSA package

- One easyTrack terminal
- One mast mount kit
- One interconnection box
- Two alert buttons with 50-meter cable
- One 20 meter cable between interconnection box and antenna
- One test led/button with 50 meter cable

### Capsat® Ship Security add-on/TT-3042SSA

The basic principle of the Capsat® Ship Security add-on solution is to use the existing Inmarsat TT-3020C transceiver onboard the ship, add alert buttons, as well as an interface panel to the installation and make the required SSA software upgrade.

### Description of the TT-3042SSA package

- TT-3042SSA interface panel with build in test/led button
- Capsat® Ship Security add-on software upgrade
- Two alert buttons with 50 meter cable
- One meter ARCNET cable for interface panel

### SSA Capsat® Manager
